Greg LeGrande called the meeting to order at 7 pm

1). Buffalo Bayou Partnership (BBP) Update on Buffalo Bayou Park –Trudi Smith, Buffalo Bayou Partnership Director of PR and Events

Trudi Smith reviewed the progress of the Buffalo Bayou Park. The \$58 million park project consists of 168 acres along the Buffalo Bayou from Shepherd to Sabine and is expected to be completed by the summer of 2015. Ongoing developments within the project are a skate area, concession stand, playground, food trucks, restrooms, information area, art exhibition area, dog park, performing arts area (300 seats), fountain, gardens, bringing back Lost Lake, a new “grab & go” food venue with private event space, hike-bike trails, 80 parking spaces (access to 400 free “jury parking” spaces at city lot H during evenings & weekends). Additional park amenities are canoe rental and launch, pavilion rental, bridges, 19 covered rest areas, an 11 acre prairie with native grass, plants & trees(14,000 native trees planted) and lunar lighting. Activities include boat tours, walking tours, kayaking, regatta, crawfish festival. Recent funding by the Brown Foundation will open up the water storage cistern <http://buffalobayoupark.org/the-water-works-underground-cistern-a-historic-houston-space-with-enormous-potential/> under the park in fall 2015 to the public. Park security is being handled with patrols by off-duty HPD officers. BBP will be responsible for maintenance of the park.

2). Metro Police Department Adopt a Bus Stop Program – Officer John Kossie

Officer Kossie spoke about Metro’s Adopt-a-Shelter program and anti-crime and graffiti efforts. Individuals or businesses may “adopt” a bus or train stop shelter. Participants are asked to keep an eye out for prevent vagrancy, trash, and graffiti and to report any suspicious activity to METRO police. In exchange, they may get their name on a plaque and also METRO ride passes. With approval, participants can decorate the shelters (but no advertising). There are 12,000 bus/train stops & shelters, so lots are available for adoption.
